Sub. West Bengal University of Health Sciences, Kolkata - Recognition of MS(Ophthalmology) qualification in respect of students being trained at R.G. Kar Medical College, Kolkata.

Sir,

The Postgraduate Committee appointed by Board of Governors at its meeting held on 07.05.2011 considered the Council Assessor report (April, 2011) on the standard of examination and other teaching facilities available at R.G. Kar Medical College, Kolkata for purpose of recognition of MS(Ophthalmology) qualification granted West Bengal University of Health Sciences, Kolkata. The Committee decided as under:-

The Postgraduate Committee appointed by the Board of Governors considered the Council Assessor report (April, 2011) and decided to recommend that MS(Ophthalmology) qualification granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at R.G. Kar Medical College, Kolkata be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 1(One) student per year.

The Postgraduate Committee further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

- 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are requested to notify the above qualification at the earliest.
